## Content

A complaint dated 12.12.2023, of Shri Ashish Kashyap was received in CBI, ACB Chhattisgarh on 11.01.2024. Another complaint dated Nil of Shri Lokesh Kumar of village Suabodi was received in the branch on 29.05.2024.

It is alleged in the complaint of Shri Lokesh Kumar and Shri Ashish Kashyap that various private persons have entered into criminal conspiracy with the officials of SECL (officials of Various Committee responsible for determining eligible asset owner/justified claimant) and defrauded the public Exchequer of over 9 crore.

The Discreet Verification of the said complaints has disclosed that Shri Khusal Jaiswal has claimed and received compensation worth more than Rs.16034833/- (Rupees One Crore Sixty Lakh Thirty Four Thousand Eight Hundred Thirty Three) for houses constructed on Govt. land or other's land located in villages like Malgaon, Amgaon (Various phases in Amgaon) on more than 7 occasion in his name or in the name of his immediate family members.

That Shri Rajesh Jaiswal has claimed and received compensation worth more than 18365570/- (one crore eighty three lakh Sixty Five thousand five hundred seventy five) for houses constructed on Govt. land or other's land located in villages like Malgaon, Amgaon (Various phases in Amgaon) on more than 9 occasion in his name or in the name of his immediate family members.

That as per the EXTRACT OF THE APPROVED MINUTES OF THE 326TH MEETING OF THE BOARD OF DIRECTORS OF SOUTH EASTERN COALFIELDS LIMITED HELD ON MONDAY, THE 18TH JULY, 2022 AT NEW DELHI, for being eligible for compensation for homestead, the claimant must have been permanent resident of the acquired village/the acquired land or ordinarily residing in the project area on the date of publications of above notifications i.e. u/s 9 (I) of CBA Act, which means the claimant must have been residing in the project area for at least six months in a year for at least the preceding five years. (3 years in case of Landless homestead).

That Shri Khusal Jaiswal and Shri Rajesh Jaiswal have applied for compensation of Assets (Houses) on multiple occasions and while applying for compensation have given affidavit that they do not own any other house on the land

acquired by SECL and despite this they have applied and received compensation on multiple occasions later on. Therefore, they have cheated the public Exchequer by entering into Conspiracy with other unknown persons and unknown officers of SECL.

Further, that the primary requirement for eligibility of any claim for any sort of compensation by SECL was that the said assets like Homestead, wells, trees etc. should have been constructed before publication of notification of Section 9 of CBA (A&D) Act, 1957/under Section 11 of LA Act, 1894 or both / on the date of land vested with the State / Central Government which is 2004, 2009, and 2010. There is credible information that the houses for which aforementioned suspects have received compensation were constructed much later i.e. after the said land had been vested with the State / Central Government.

The Multiple claims of compensation for homestead by Shri Khusal Jaiswal and Shri Rajesh Jaiswal as described above reveal the conspiracy among Shri Khusal Jaiswal, Shri Rajesh Jaiswal (Cousins), others and SECL officers who have not verified/checked the claim and the requirements for the eligibility of compensation for Homestead before disbursing the amount.

Hence, the above-mentioned act of omission or commission on the part of Shri Khusal Jaiswal and Shri Rajesh Jaiswal, other unknown persons and unknown SECL officials has caused wrongful loss of Rs. 34400403/- to SECL (Public Exchequer) and thus constitute a commission of offences U/s 120 B r/w 420 of IPC, and section 13 (1) (a) r/w 13 (2) of PC Act 1988 (as amended in 2018) and substantive offences thereof.

Therefore a regular case against Shri Khusal Jaiswal, Shri Rajesh Jaiswal, Unknown Public Servants of SECL and others U/s 120 B r/w 420 of IPC, and section 13 (1) (a) r/w13 (2) of PC Act 1988 (as amended in 2018) and substantive offences thereof is being registered.
